The California DMV requires the following forms during a sale of a vehicle: a properly completed title, the Odometer Disclosure Form REG 262 (required for vehicles 10 years old and under; contact your local DMV for a copy, not available online because it is printed on security paper), a smog certification if the vehicle is more than 4 model years old (unless you obtained one within the last 90 days) and the Release of liability form REG 138 (required for all sellers).
